In dit document wordt een overzicht gegeven van de beleggingen die Philips Pensioenfonds uitsluit. Dit betekent dat het Pensioenfonds niet in deze ondernemingen en landen belegt.

Philips Pensioenfonds heeft in het MVB-beleid vastgelegd waar het Fonds niet in wenst te beleggen. Daarbij wordt onderscheid gemaakt in ondernemingen en in landen.

Ondernemingen

Philips Pensioenfonds wenst niet te beleggen in bedrijven die zijn betrokken bij de productie van controversiële wapens. Dit zijn wapens die geen onderscheid maken tussen militaire en civiele doelen en vaak vele jaren na afloop van een conflict nog slachtoffers maken. De meeste van deze controversiële wapens zijn door middel van internationale wet- of regelgeving verboden of het gebruik hiervan ligt aan banden. De lijst van Philips Pensioenfonds betreft vijf typen wapens: Anti-persoons mijnen, Biologische wapens, Chemische wapens, Clusterwapens en Nucleaire wapens.

Ook belegt het Fonds niet in bedrijven die tabaksproducten maken. Dat zijn bedrijven die omzet genereren uit de productie van bijvoorbeeld sigaretten. Ook worden bedrijven uitgesloten die een groot deel van de omzet halen uit vervuilende energiebronnen. Dat zijn bedrijven die meer dan 25% van de omzet genereren met activiteiten in olieteerzanden (extractie) en/of bruin- en steenkool (extractie en/of energieopwekking).

Ten slotte kan het Fonds besluiten niet te beleggen in ondernemingen die niet voldoen aan de internationale richtlijnen voor maatschappelijk verantwoord ondernemen (MVO). Philips Pensioenfonds hanteert daarvoor de Global Compact principes, de OESO-richtlijnen en de UNGP's. Voordat een onderneming uitgesloten wordt, wordt eerst een dialoog (zie 'zorg voor beleggingen') met de betreffende onderneming gevoerd. Indien met deze dialoog niet het gewenste resultaat wordt bereikt, kan het Fonds besluiten om deze onderneming uit te sluiten op basis van schendingen van internationale richtlijnen. Het Fonds stelt jaarlijks een lijst van uitgesloten ondernemingen vast.

Landen

Daarnaast belegt het Fonds niet in staatsobligaties van landen waartegen substantiële internationale sancties zijn afgekondigd die het gehele land of personen treffen die deel uitmaken van de regering en landen die duidelijk achterblijven op ESG-gebied. Het Fonds stelt jaarlijks een lijst van uitgesloten landen (voor staatsobligaties) vast. Daarnaast worden bedrijven uitgesloten waar de overheden van deze uitgesloten landen het voor het zeggen hebben (staatsbedrijven).
